AMENDMENTS TO THE TRADE MARKS ACT (CAP 98) AND TRADE MARKS RULES, 2000

Trade Marks Act (Amendment) Order, 2017

- Section 2 of the Trade Marks Act (Chapter 98), is amended –
 - a) by deleting the definition of “Minister “ and by substituting the following new definition therefor –

“”Minister” means the Minister of energy in the Office of the Prime Minister;”;
 - b) by inserting the following new definition immediately after “infringing material” –

“International Bureau” has the same meaning as Article 2(1) of the Madrid Protocol;

“international trade mark (Brunei Darussalam)” means a trade mark which is entitled to protection in Brunei Darussalam under the Madrid Protocol or a trade mark prescribed by the Minister (by Rules made under section 53A) as an international trade mark (Brunei Darussalam);

“Journal” means the Trade Marks Journal referred to in section 74;

“Madrid Protocol” means the Protocol relating to the Madrid Agreement concerning the International Registration of Marks, adopted at Madrid on 27th June 1989, as revised or amended from time to time;
- Section 4 of the Act is amended, in subsection (1), by deleting “visually” from the first line.
- Section 73 of the Act is amended, in subsection (1) by deleting “*Gazette*” from the first line and by substituting “Journal” therefor.
- Section 74 of the Act is repealed and the following subsection is substituted therefor –

“Power of Registrar to publish journal

74. (1) The Registrar may publish or cause to be published a journal to be called the Trade Marks Journal in which there may be published such documents and information relating to a registered trade mark or an application for registration as the Registrar thinks fit.

(2) For the avoidance of doubt, the Journal shall be the official journal of record.

(3) A publication specified under the Journal need not be in a documentary form.”.

- Part II of the Act is amended by inserting the following new provisions immediately before “Protection of Well-Known Trade Marks” –

“INTERNATIONAL MATTERS

The Madrid Protocol etc

Power to make provision giving effect to Madrid Protocol etc.

53A. (1) The Minister may, with the approval of His Majesty the Sultan and Yang Di-Pertuan, make rules to give effect in Brunei Darussalam to the provisions of the Madrid Protocol or of any treaty, convention, arrangement or engagement relating to trade marks to which Brunei Darussalam is a party.

(2) Without prejudice to the generality of subsection (1), rules may, in particular, be made to provide for —

(a) the making of applications for international registrations by way of the Registry as office of origin;

(b) the procedures to be followed where the basic Brunei Darussalam application or registration fails or ceases to be in force;

(c) the procedures to be followed where the Registry receives from the International Bureau or any body specified in the rules a request for extension of protection to Brunei Darussalam;

(d) the effects of a successful request for extension of protection to Brunei Darussalam;

(e) the transformation of an application for an international registration, or an international registration, into a national application for registration;

(f) the communication of information to the International Bureau; and

(g) the payment of fees and amounts prescribed in respect of applications for international registrations, extensions of protection and renewals.

(3) Provision may also be made in the rules to apply in relation to an international trade mark (Brunei Darussalam) the provisions of section 22 and Part IV.”.

Trade Marks (Amendment) Rules, 2017

- **Amendment of rule 2 of R1 of Chapter 98**

Rule 2 of the Trade Marks Rules, in these Rules referred to as the principal Rules, is amended, in subrule (1), in the definition of “publish”, by deleting “*Gazette*” and by substituting “Journal” therefor.

- **Amendment of rule 26**

Rule 26 of the principal Rules, is amended, in subrule (1), by deleting “*Gazette*” and by substituting “Journal” therefor.

- **Amendment of Third Schedule**

The Third Schedule to the Principal Rules is amended in Part I and Part II in accordance with the current version of the International Classification of Goods and Services (Nice Classification).

CLASSIFICATION OF GOODS AND SERVICES

PART I

CLASSES OF GOODS

- Class 1 Chemicals used in industry, science and photography, as well as in agriculture, horticulture and forestry; unprocessed artificial resins, unprocessed plastics; manures; fire extinguishing compositions; tempering and soldering preparations; chemical substances for preserving foodstuffs; tanning substances; adhesives used in industry
- Class 2 Paints, varnishes, lacquers; preservatives against rust and against deterioration of wood; colorants; mordants; raw natural resins; metals in foil and powder form for use in painting, decorating, printing and art
- Class 3 Bleaching preparations and other substances for laundry use; cleaning, polishing, scouring and abrasive preparations; non-medicated soaps; perfumery, essential oils, non-medicated cosmetics, non-medicated hair lotions; non-medicated dentifrices
- Class 4 Industrial oils and greases; lubricants; dust absorbing, wetting and binding compositions; fuels (including motor spirit) and illuminants; candles and wicks for lighting
- Class 5 Pharmaceuticals, medical and veterinary preparations; sanitary preparations for medical purposes; dietetic food and substances adapted for medical or veterinary use, food for babies; dietary supplements for humans and animals; plasters, materials for dressings; material for stopping teeth, dental wax; disinfectants; preparations for destroying vermin; fungicides, herbicides
- Class 6 Common metals and their alloys, ores; metal materials for building and construction; transportable buildings of metal; non-electric cables and wires of common metal; small items of metal hardware; metal containers for storage or transport; safes
- Class 7 Machines and machine tools; motors and engines (except for land vehicles); machine coupling and transmission components (except for land vehicles); agricultural implements other than hand-operated; incubators for eggs; automatic vending machines
- Class 8 Hand tools and implements (hand-operated); cutlery; side arms; razors
- Class 9 Scientific, nautical, surveying, photographic, cinematographic, optical, weighing, measuring, signalling, checking (supervision), life-saving and teaching apparatus and instruments; apparatus and instruments for conducting, switching, transforming, accumulating, regulating or controlling electricity; apparatus for recording, transmission or reproduction of sound or images; magnetic data carriers, recording discs; compact discs, DVDs and other digital recording media; mechanisms for coin-operated apparatus; cash registers, calculating machines, data processing equipment, computers; computer software; fire-extinguishing apparatus
- Class 10 Surgical, medical, dental and veterinary apparatus and instruments; artificial limbs, eyes and teeth; orthopaedic articles; suture materials; therapeutic and assistive devices adapted

- for the disabled; massage apparatus; apparatus, devices and articles for nursing infants; sexual activity apparatus, devices and articles
- Class 11 Apparatus for lighting, heating, steam generating, cooking, refrigerating, drying, ventilating, water supply and sanitary purposes
- Class 12 Vehicles; apparatus for locomotion by land, air or water
- Class 13 Firearms; ammunition and projectiles; explosives; fireworks
- Class 14 Precious metals and their alloys; jewellery, precious and semi-precious stones; horological and chronometric instruments
- Class 15 Musical instruments
- Class 16 Paper and cardboard; printed matter; bookbinding material; photographs; stationery and office requisites, except furniture; adhesives for stationery or household purposes; artists' and drawing materials; paintbrushes; instructional and teaching materials; plastic sheets, films and bags for wrapping and packaging; printers' type, printing blocks
- Class 17 Unprocessed and semi-processed rubber, gutta-percha, gum, asbestos, mica and substitutes for all these materials; plastics and resins in extruded form for use in manufacture; packing, stopping and insulating materials; flexible pipes, tubes and hoses, not of metal
- Class 18 Leather and imitations of leather; animal skins and hides; luggage and carrying bags; umbrellas and parasols; walking sticks; whips, harness and saddlery; collars, leashes and clothing for animals
- Class 19 Building materials (non-metallic); non-metallic rigid pipes for building; asphalt, pitch and bitumen; non-metallic transportable buildings; monuments, not of metal
- Class 20 Furniture, mirrors, picture frames; containers, not of metal, for storage or transport; unworked or semi-worked bone, horn, whalebone or mother-of-pearl; shells; meerschaum; yellow amber
- Class 21 Household or kitchen utensils and containers; combs and sponges; brushes, except paintbrushes; brush-making materials; articles for cleaning purposes; unworked or semi-worked glass, except building glass; glassware, porcelain and earthenware
